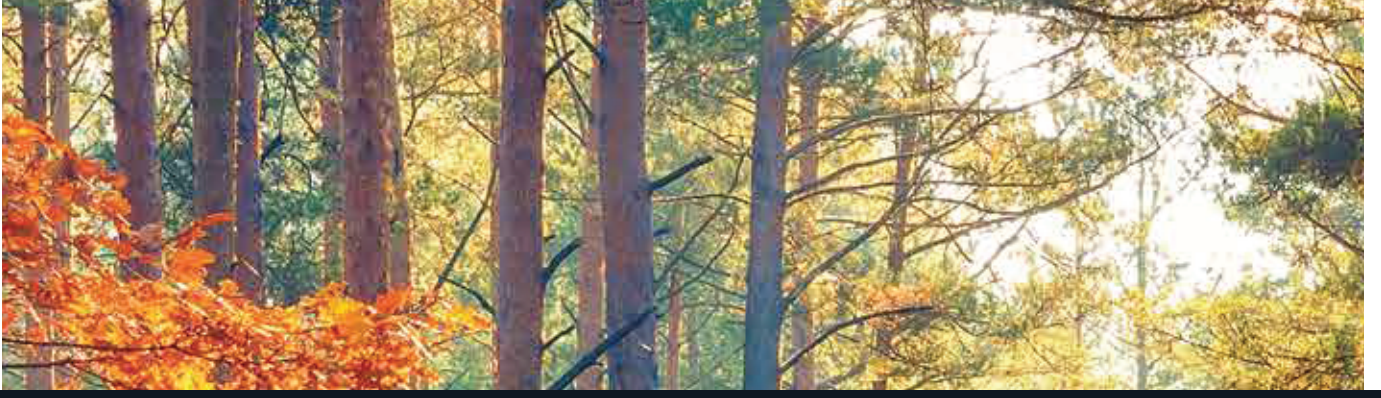

1 Warrantor

AREA FLOORS ZEMİN KAPLAMALARI SANAYİ VE TİCARET ANONİM ŞİRKETİ, Ömerli, İlgaz Sk. NO:7/1, 34275 Arnavutköy/İstanbul a manufacturer of Vinyl SPC, gives the following warranty in addition to legal rights regarding defects in wall and floor coverings purchased.

2 Warranty period

The warranty period depends on the product category, product series, technical specifications and the intended use of the product purchased. The warranty period begins with the date of the invoice and the purchase of the product by the person entitled to the warranty. In the event of a warranty claim, the warranty period will not be extended, and a new warranty period will not be started.

3 Scope and performance under this manufacturer's warranty

3.1 The warranty applies to:

The warranty is limited to latent defects. These are defects that are not visible before or during installation of the flooring.

If damage occurs during the warranty period, the manufacturer will provide financial compensation under this warranty. Depending on the warranty given, the payment will be reduced each year (e.g. 10-year warranty is reduced by 1/10 each year; 7-year warranty is reduced by 1/7 each year).

3.2 Warranty conditions for:

3.2.1 Wear Warranty

This is limited to wear on the surface of the boards. The wear must be easily visible and cover at least 10% of the installed wall. Gloss reduction or surface scratches are not considered surface wear.

3.2.2 Lifetime Structural Warranty

AREAFLOORS products are carefully inspected during the production process before packaging and are guaranteed to be free of manufacturing defects, except for minor color deviations that cannot be technically prevented and minor defects that do not significantly reduce their use value.

4 Warranty conditions

This warranty applies to AREAFLOORS vinyl SPC wall products and is valid only for use in indoor applications subject to normal traffic.

This warranty provision applies only to upholstery products at the original installation site from the date of purchase.

SPC wall panels are generally moisture resistant, making them suitable for use in humid environments such as bathrooms or kitchens. However, excessive and continuous exposure to moisture, especially standing water, can eventually affect the adhesive bonds and surface finish, leading to potential deterioration.

SPC WALL PANEL & TILES WARRANTY CERTIFICATE

Before installing the wall, please read the installation instructions carefully from start to finish and strictly follow the instructions. Final inspection and approval is the responsibility of the customer. Before installation, inspect the material for visible defects/damage, including defects or inconsistencies in daylight, color or gloss; check the edges of the tiles/panel for straightness and any damage. No claims for surface defects after installation will be accepted. Incorrect installation will void the Warranty.

AREAFLOORS cannot assume responsibility for the suitability of the wall material and accompanying products for each individual installation, as AREAFLOORS has no control over the correct application by the installer. If a single part is questionable in appearance or size, the installer must not use it.

Maintenance and cleaning should be carried out according to the current maintenance instructions. Timely maintenance of the surface coating guarantees the long-term durability of AREAFLOORS walls. Improper maintenance of the surface coating will void this warranty. Full installation and cleaning instructions can be found on the product packaging or at www.areafloors.com.tr.

This limited warranty does not apply to damage caused by improper handling or use of the wall, inadequate maintenance, modification, and repair of the object by third parties without prior authorization. Some variations in color and pattern of the same product reference/party can be expected and are not considered as defects.

AREAFLOORS is not responsible and will not accept claims for the installation of material that does not meet customer expectations visually or in terms of shade consistency or variation. Installation of the material should be considered approval of the pattern, color, appearance and all other visual factors including but not limited to squareness and thickness.

The warranty covers only the repair and replacement of the wall. Any other liability is excluded if permitted by law. AREAFLOORS is in no way liable for consequential damage such as business interruption, dismantling costs, loss of profit, etc.

5 Warranty exclusions

Warranty claims do not apply to damage caused by the following.

- Problems caused by alkalis, hydrostatic pressure, expansion and contraction between plates/tiles,
- Damage caused by exposure to extreme cold, heat or dryness,
- Damage caused by irregularities in the subgrade, improper subgrade preparation or improper use of subgrade materials,
- Damage resulting from surrounding structures, floors, fixtures, furniture, moldings, coverings, or any other components not related to the structural integrity or dimensional stability of the wall panel are not covered by the warranty.
- Damage resulting from mold and mildew growth due to prolonged exposure to moisture.
- Damage caused by adhesives or tapes, stains, scratches, gouges, scuffs, punctures, tears, cuts, marks, burns, accidents, lack of proper furniture rests; improper storage and handling or incidents such as fire, flood (as well as plumbing leaks such as overflowing sinks or similar water damage) or abuse,
- Cuts, cracks, bumps, contamination caused by sharp objects, animal claws/nails, etc.,
- Improper care or abuse,
- Loss of gloss consistent with normal wear and tear over time,
- Dissatisfaction, trouble or damage caused by the use of unsuitable installation tools and/or materials,
- Failure to follow the installation instructions and maintenance guidelines recommended by AREAFLOORS,
- Wall coverings installed in inappropriate places,
- Insect infestation after shipment from the factory,
- Factory untreated surfaces, including, but not limited to, remodeling or recoating,

6 Recommendations

6.1 Ventilation and environmental conditions

In order for SPC wall panels to maintain their form, regular air circulation should be ensured in the environment and ventilation should be provided against moisture accumulation. Sudden temperature changes should be avoided and heating-cooling systems should be used gradually. In this way, the panels remain long-lasting and aesthetic.

6.2 Heavy items

Leaning furniture, cabinets or white goods tightly against the panel surface can cause deformations over time due to marks or pressure. Leaving a gap of a few centimeters is beneficial for longevity.

7 Assertion of the warranty claim

The customer must submit a warranty claim with the following documents:

- Informative photos.

Original invoice with proof of purchase date, supplier/dealer stamp.

The warranty claim must be made within 15 days of the defect appearing, submitted in writing to the retailer who sold you the material. After verifying the claim, the retailer will inform AREAFLOORS and, if necessary, an inspection will be arranged.

AREAFLOORS reserves the right, before accepting a complaint, to inspect the affected floor on site or to have it inspected by a third party, to request photographs of the affected boards and the surrounding environment, or to request the boards themselves for inspection of the defect.

If a defect is confirmed, AREAFLOORS will arrange for the defective floor to be repaired or replaced. If the floor needs to be replaced, the replacement material will be of the same design and color as the original. If the original floor is no longer available, another AREAFLOORS flooring product of equal value will be supplied.

If a defect is confirmed, AREAFLOORS will arrange for the defective floor to be repaired or replaced. If the floor needs to be replaced, the replacement material will be of the same design and color as the original. If the original floor is no longer available, another AREAFLOORS flooring product of equal value will be supplied.

Repair or replacement of all or part of the flooring is at the discretion of AREAFLOORS, and all labor costs will not be covered. Other costs associated with installation, repair or replacement will not be covered under this warranty. Any attempt to repair, refinish or replace the defective product prior to inspection by an AREAFLOORS retailer will void this warranty.

AREAFLOORS will repair or replace a floor once during the warranty period.

8 Exclusion of liability

The warranty is non-transferable and applies only to the original purchaser (whose name appears on the invoice) and will expire upon transfer or resale of the product or installation site.

All information contained in brochures, data sheets, advertising and marketing materials and statements made by sales representatives or dealers are general information and are not binding on AREAFLOORS. Sales representatives and dealers are not authorized to modify the warranty.
